Molde Stadion has various hospitality areas with different concepts. All seats in hospitality are outside.



#### MOLDE AIRPORT ÅRØ

Molde International Airport is situated 5 km east of the city center and the stadium.

Full operational description is available at www.ippc.no, under AIS publications/AIP Norway.

Operations outside opening hours will be granted when pre-noticed.

Molde Airport Årø has approval in category 4D, limiting aircraft size being Airbus A330 – Boeing 757-200 or similar. The runway (RWY) has a landing distance (LDA) of 1980 meter both ways for RWY 07 and RWY 25. Total RWY available is 2120 meter for RWY 07 (TORA/ASDA), and 2080 meter for RWY 25 (TORA/ASDA). ### **GROUND ROULES AKER STADIUM**

Entry to the stadium is expressly subject to acceptance by the visitor of Norwegian Law, these stadiums rules and regulations of FIFA, UEFA, Norwegian Football Association, Norsk Toppfotball in respect of the relevant competition. Entry to the stadium shall constitute acceptance of the stadium regulations.

We are happy to welcome you to the stadium. For your own and all spectators' safety we want to draw your attention to the following important rules and regulations:

- In the interest of safety, all spectators must only occupy the seat allocated to them with their match ticket. No movement
  is allowed. Persons occupying the wrong seat will be evicted.
- The obstructions of access ways exit and entrances, stairways and like places is strictly forbidden. Nobody entering the stadium shall be permitted to climb any structures within the stadium.
- All persons entering the stadium accept that the organizer's right to search any person entering the stadium and to refuse entry to or eject from the stadium any person refusing to submit to such a search.
- The following articles must not be brought within the stadium:
  - o Knives, weapons, or any article that might be used as a weapon and/or compromise public safety.
  - Fireworks Pyrotechnics
  - Smoke canisters
  - Bottles of glass or plastic
  - Alcohol or other types of drugs
  - o Any audio, visual or audio-visual material for recording or transmission
  - o Animals, except for service-animals
  - Laser devices
  - Any mosaics, banners, flags etc with commercial, religious, pornographic, political or racist content, or that directly or indirectly discriminate against persons or groups. All banners are subject to search at gate and may be refused.
- Smoking, and the use of electronic cigarettes/vapors is not allowed in the stadium.
- The organizer is NOT responsible for any accident/injury, loss, or damages to persons/property in or around the stadium.
- No guarantees can be given by the organizer that the event will take place in a date and the organizer reserves the right to reschedule the event without notice and without any liability whatsoever.
- There will be NO refund of any ticket costs, travel costs etc. if an event is abandoned.
- Persons influenced by alcohol, or any other kind of drugs will be rejected from the stadium.
- No goods (including literature) of any nature may be distributed or offered either free or for sale by any person within the stadium without permission of the organizer.
- A television surveillance system is in function outside and inside of the stadium.
- Mobile telephones are permitted within the stadium if they are used for personal or private use only.
- Tickets may not be offered for sale within the stadium area without the prior written permission by the organizer.
- Any individual who has entered any part of the stadium designated for the use of any group of supporters to which he
  does not belong, may be ejected from the stadium either for the purpose of his own security or any other reason.
- All times whilst present in the stadium, persons must comply with all instructions of the organizer, any steward, or police
  officer.

The organizer reserves absolutely the right to eject from the Ground any persons failing to comply with any of the Stadium Regulations.

Any fan activities including mosaics, banners or flags must be pre-approved by UEFA. For approval the visiting club must send images, size and description of the planned fan activities to Molde FKs chief of security, Arve Tovan, no later than six days prior to the match. This will be forwarded to UEFA within the deadline, five days before the match.

### Prohibited commercial activities in Norway

With this document The Football Association of Norway inform foreign teams playing matches in Norway that commercial activities related to alcohol, tobacco and betting companies is prohibited in Norway.

Thus, according to the UEFA Equipment regulations edition 2022, article 27.02: Any bans or restrictions imposed by the domestic legislation of the country in which a UEFA competition match is taking place also apply, no teams playing in Norway may advertise such products in any way while they play in Norway. The ban is valid for both on and off pitch equipment.

#### Tobacco:

All forms of advertising for tobacco products are prohibited.

No tobacco products may be included in the advertising of any other goods or services.

A brand that is primarily known as a tobacco brand cannot be used in advertising for other goods or services.

#### Alcohol

Advertising of alcoholic beverages is prohibited. The prohibition also applies to advertising for other goods with the same brand or characteristics as any alcoholic beverages. Beverages containing alcohol must neither be included in the advertisement of other goods or services.

#### Betting:

It is not allowed to promote or announce betting services in connection with sports- or other competitions in Norway. The only exception is betting provided by the state-owned company "Norsk Tipping".

The regulations also affect advertising of messages in a way that makes it possible for the public to understand that it is a betting company that is promoting the message, no matter what the message is. If a not insignificant part of the public perceives that the sender of a message or an advertisement is an illegal betting company, the message itself is illegal.
